

# **Illumination Foundation Shelter Opens**

The Navigation Center and Recuperative Care facility at 3535 West Commonwealth Avenue opened this week and is already serving over 50 clients in the Navigation Center and 10 in the recuperative care unit. When fully operational, the facility will provide



up to 90 navigation center beds and 60 recuperative care beds. The facility will assist clients on a path to housing and other needed services. The Fullerton location is the first in the

County to provide both recuperative care and navigation in the same facility and will serve as a model for

other needed services.

future facilities. This location combined with the Placentia and Buena Park facilities will assist in placing Fullerton's most vulnerable into shelter to obtain needed services. The Illumination Foundation (IF), a non-profit organization, is the lessee and operator of the facility and the City has contributed funding for

the tenant improvements as well as is acting as the Guarantor of the Lease with the private property owner. The City assisted IF to completely rehabilitate the facility in less than six months by providing enhanced plan check and inspections.

#### San Onofre Begins New Chapter as Fuel Transfer Operations End

ROSEMEAD, Calif., Aug. 7, 2020 — The decommissioning effort at the San Onofre nuclear plant achieved a major milestone today when the last of 73 spent nuclear fuel canisters was safely stored in the Holtec dry storage system. The fuel is now one step closer to being ready for relocation to an off-site facility when one becomes available. Currently, no such federally licensed facility exists.

Both wet storage of spent fuel in pools of water and dry storage in welded stainless-steel canisters are extremely safe. However, dry storage offers additional safety benefits: The dry storage systems at San Onofre have more than twice the seismic rating as the spent fuel pools, and dry storage requires no electricity because the fuel is convection cooled with ambient air.

"Our commitment remains ensuring spent nuclear fuel is safely stored and that it can be transported to an off-site facility in the future," said Doug Bauder, SCE vice president and chief nuclear officer. "We are developing a strategic plan to help us explore opportunities for advancing various alternatives to get the spent fuel off-site, as well as make sure that our fuel is ready for pickup when the opportunity presents itself."

SCE expects to release the strategic plan early next year. It will explore alternatives for relocating San Onofre's spent fuel to an off-site facility, either for permanent disposal or temporary storage, and identify actions that SCE can take to advance various alternatives. The plan also will include opportunities to collaborate with like-minded stakeholders and the community.

#### A New Chapter

With all the spent fuel — 123 canisters, including the 50 in the TN-NUHOMS system — in dry storage, most of the plant now becomes a deconstruction site. SCE issued a <u>Notice of Deconstruction</u> in January, and work to dismantle San Onofre began the following month. Initial projects included asbestos removal from inside the containment domes and shipping the Unit 1 <u>reactor pressure vessel</u> to a disposal facility in Clive, Utah. Both have been completed successfully. In the next couple of months, offices will be relocated to new trailers in a parking lot on the north side of the site. That will clear the way for building demolition to begin early next year. Employees who can continue to telework due to COVID-19 guidelines are doing so.

"For the next stages at San Onofre, we've developed a streamlined organization that is focused on providing oversight of our decommissioning contractor and safely managing the spent fuel," Bauder said. "Much of the work coming up will be inside the containment domes and preparing for the removal of lots of steel and concrete."

That material will be mostly transported via railcar to disposal sites in Utah, Arizona and Texas. For the duration of the project, SCE will continue to issue quarterly updates to surrounding residents on activity at San Onofre. # **Business Assistance Team**

The goal of the Business Assistance Team (BAT) is to provide education and outreach to all businesses regarding on how to re-open safely and meet the Governor's requirements. The BAT is a three-person team of part-time Parks and Recreation employees who were selected for their excellent communication and outreach abilities.

The team approaches all businesses to discuss the required signage (industry specific checklist and attestation) and discuss and encourage mandatory face coverings/mask and social distancing. In addition, they provide information on business grants/loans, outdoor dining/retail use and other helpful information. In addition, they have developed multiple handouts such as COVID-19 testing sites and childcare options.

The team in week two has had excellent success rates and all businesses have been pleasant and has thanked the team for the visit. Our BAT team has personally delivered checklists, masks and attestation for the businesses. All our handouts are in English, Spanish and Korean.

# **Outdoor Dining and Retail Program**

#### **Water Production**

Staff perform a variety of field lab sampling as required by the state of California. This includes water samples from our wells, reservoirs and water distribution system. Control valves and plug valves regulate water between different pressure zones or elevations within the water system and require preventative maintenance (PM). Well production is a total of gallons produced from City water wells, and MWD production gallons reflect water purchased from Metropolitan Water District.

This Division is responsible for the maintenance of the water transmission and distribution system that delivers water to City residents, businesses, and industries. The water transmission and distribution system consists of 430 miles of water pipeline, more than 31,500 metered services, 4,000 fire hydrants, and 12,000 valves. On an annual average, we respond to 4,600 underground service alert tickets.

# Water Repair & Water Quality

On August 4, a crew from the Water Construction section responded to 1420 Miramar Drive to repair a water main break. The repair crew installed 5.5 feet of 8-inch-diameter ductile iron pipe. Water Construction crew members working in conjunction with our Street Division will repair and replace sections of the damaged street.







#### **Water Quality Specialist**

The Water Quality Specialist monitors routine and main break bacteriological results and takes action if a positive sample is detected. Per California regulation, water services that present a hazard to the water supply are required to have a backflow prevention device to prevent polluted or contaminated water from entering the potable water system. These devices must be tested yearly to ensure they are in working order. The Water Quality Specialist is also responsible for water conservation complaints and assists in responding to billing disputes.



An early morning fire destroyed a large portion of the 100 block of West Commonwealth on June 23, 1950. It was determined that the fire originated in the garage of the McCoy and Mills Ford dealership, but quickly spread east to

the adjacent Fullerton Hotel, and north to the Pacific Citrus Products (later Hawaiian Punch) plant facing Amerige. Less than a year later, the Ford agency scooped up a four-acre parcel and broke ground on their new \$100,000 facility at 700 West Commonwealth. Northern Orange County's oldest Ford dealer is still in business, at this location, today.

Here's how it works: When you place items on hold, library employees will pull the available items from the shelves and process them for pickup. Once the hold becomes available, you will receive an automated notification by email or phone that the items are ready. You can also check your holds status

online via your account at www.fullertonlibrary.org under the "Holds" tab in "My Account."

Once you have been notified that your items are ready, call the library Monday through Friday from 11:00 a.m.-4:00 p.m. at (714) 738-6333 to make an appointment to pick them up. You will have 14 days from the time of notice to pick up your materials. (If you can't call, send us an email at info@fullertonlibrary.org.)

Due to high demand, the library requires a minimum of two to three full business days to process requests. (During this time there may also be a slight delay in our ability to reach out to you by email or phone.) We ask you to be patient as we work hard to fulfill your requests while taking extra precautions, including quarantining returned books for 96 hours, to ensure your safety. Returns are not accepted during curbside pickup. To return your items, please use the outdoor book drop between Monday at 9:00 a.m. and Friday at 4:00 p.m.


