### COVID-19 Testing Available for All

Testing for COVID-19 is not just for those showing symptoms. In fact, it is important that even those with no symptoms (asymptomatic) are tested, specifically younger adults, since it is known that those without symptoms who get out and about, can unknowingly spread the virus to other at risk individuals. With colder weather coming and more indoor events, to include family gatherings, taking advantage of testing is critical for continued health and safety and ensuring that Orange County can move lower in the State's Tiered system for re-openings. The City is working with the County of Orange to sponsor local pop-up testing sites in Fullerton (more information soon!) ### City Receives Government Finance Officers Association Award for Popular Annual Financial Report. CAFR Release in January.

The City was notified by the Government Finance Officers Association (GFOA) that its Popular Annual Financial Report (PAFR) for the year ending June 30, 2019 received an Award for Outstanding Achievement. Using information from our externally audited Comprehensive Annual Financial Report (CAFR), the PAFR or Community Report highlights the City's financial position and capital investments, and offers useful information about the City, including where revenues come from and how they are spent to operate our City. The City is one of a few Orange County cities to take information from the more technical CAFR in order to make the financial information more available and understandable to residents. The City's CAFR for year ending June 30, 2020, which is normally provided to Council before the end of December, will instead be presented before the end of January, 2021. Our financial reporting to the State of California (the City's Financial Transaction Report) will be remitted per the January 31, 2021 deadline. While the City contracts with an external auditor to complete the CAFR, it is City accounting staff which develops all of the information and compile it for the auditors. Over the course of this calendar year, we have seen a complete turnover in our accounting staff of four persons, including the Accounting Supervisor. We welcome our new employees, but due to training, the delays of COVID-19, and catching up on monthly close-outs for Fiscal Year 2019-20, the actual audit will not start until November 30th.





## CITY COUNCIL MEETING REVIEW

During the COVID-19 pandemic, the City Council and all City Commissions/Committees may conduct meetings via video conferencing, per exemptions allowed under the Governor's Executive Order N-29-20. Council meetings are also broadcast live on [Channel 3](#), Facebook Live, and streamed online.

The City Council met on October 20th with Closed Session beginning at 5:00pm and Regular session beginning at 6:30pm and concluding at approximately 11:30pm.

Pastor Louie Gutierrez, Freedomhouse Church, gave the invocation. Mayor Fitzgerald led the Pledge of Allegiance.

There was no report out from the City Attorney on Closed Session items.

There was one (1) presentation made: November 3, 2020 Vote Centers and Vote By Mail Ballots. City Clerk Lucinda Williams made a presentation.

There were e-comments submitted regarding accolade to City employees for their hard work and services they provide to the community, reinstating Bastanchury Tree Farm as a park, electronic abuse, request to increase the online comment characters, and request of support on Measure S.

There were approximately 13 public comments regarding homelessness, remove Bastanchury Tree Farm for the City's surplus list, Community Choice Energy, advanced notice of meetings, participation and attendance in committee meetings, and thank you to City staff for assistance in rental assistance paperwork.

The City Manager provided a reminder for electronic sign-ups on the City's website for notification of City meetings.

Consent Calendar Items:

- ◇ Item #7: Personnel Management System Changes Related to Revising the Principal Civil Engineer—Water Class Specification and Salary Range Reassignment. This item was pulled and discussed. The item passed 4-1 (Whitaker opposed).

**The October 20, 2020 City Council was held in the City Council Chambers.**

Social Distancing and Face Covering requirements were in effect for members of the public. Limited public capacity was available in the Council Chambers and additional overflow was available. In person Public Comments are allowed but e-comments and emailed comments were highly encouraged.

Consent Calendar Items:

- ◇ Item #4: Code Amendments Pertaining to Regulation of Commercial Cannabis Activities Citywide—Second Reading of Ordinance. The item was pulled and discussed with many public commenters. Mayor Fitzgerald moved, seconded by Councilmember Whitaker, to table the item. On a vote of 4-1 (Silva opposed), this item was tabled. Now, you ask, what does that mean? Tabling an item is a parliamentary procedure that neither approves nor rejects an item, nor does it continue it to a date in the future where the item would be heard at that time. Only the members who vote in the affirmative to table an item can move to un-table an item. The item is tabled as it was presented, in this case, it was the Second Reading of an ordinance. If it is ever un-tabled, it would be scheduled once again for a Second Reading.
- ◇ Item #8: Chief Information Officer Position Salary Range. This item was pulled and discussed. The item passed 4-1 (Whitaker opposed).

The remainder of the consent calendar was approved unanimously.

There was one (1) Public Hearing Item.

- Fullerton Municipal Code **Amendments Pertaining to Regulation of Short-Term Rentals**. This item was discussed and the ordinance was introduced. This item was previously heard on September 15, 2020 and continued. This item passed 4-1 (Whitaker opposed). This item will be on the November 2, 2020 meeting as a Second Reading and Adoption. If passed, the Short Term Rental amendments to the Municipal Code will become effective 30 days after.. For more information on this item, please click [here](#).

Regular Business Items:

- Issuance and Sale of 2020 Refunding Bonds to Refinance Outstanding 2013 Taxable Judgment Obligation Bonds. This item was discussed and passed unanimously. Much like refinancing your home in the current very low interest rates, the City is reviewing all of its outstanding bond financings to determine if there is an ability to save on interest due to the lower rates. This action provide authority to refund the 2013 JOBS when there is at least a 7% savings in the overall payments within the same term of the outstanding bonds.

## Water Division Updates

### Meter Shop

Meter Shop staff perform meter reading duties and respond to service calls during normal hours of operation and callouts after hours. In addition, they also turn water services on or off based on residents' needs, post water service accounts, replace water meters, water meter boxes/lids and perform repairs/tests on water meters.

### Water Production

Staff perform a variety of field lab sampling as required by the state of California. This includes water samples from our wells, reservoirs and water distribution system. Control valves and plug valves regulate water between different pressure zones or elevations within the water system and require preventative maintenance (PM). Well production is a total of gallons produced from City water wells, and MWD production gallons reflect water purchased from Metropolitan Water District.

### Water Distribution

This Division is responsible for the maintenance of the water transmission and distribution system that delivers water to City residents, businesses, and industries. The water transmission and distribution system consists of 430 miles of water pipeline, more than 31,500 metered services, 4,000 fire hydrants, and 12,000 valves. On an annual average, we respond to 4,600 underground service alert tickets.

## Water Repair & Water Quality

### Water Repairs

On October 14, a repair crew from the Water Division responded to 712 Paseo Place to repair a water main break. The crew installed a 6-inch by 20-inch repair clamp on the 6-inch-diameter cast iron pipe, and all the bolts were covered with a protective coating. The excavation was backfilled with base material to grade, and the site was secured with barricades and caution tape. The Street Division will make permanent repairs to the roadway as soon as possible.



### Water Quality Specialist

The Water Quality Specialist monitors routine and main break bacteriological results and takes action if a positive sample is detected. Per California regulation, water services that present a hazard to the water supply are required to have a backflow prevention device to prevent polluted or contaminated water from entering the potable water system. These devices must be tested yearly to ensure they are in working order. The Water Quality Specialist is also responsible for water conservation complaints and assists in responding to billing disputes.

## Watch Now! OnLine Holds Are Available For Curbside Pick-Up!



Place holds directly in our [catalog](#)! Check out our new video tutorial above. (Click on it!)

Here's how it works: When you place items on hold, library employees will pull the available items from the shelves and process them for pickup. Once the hold becomes available, you will receive an automated notification by email or phone that the items are ready. You can also check your holds status online via your account at [www.fullertonlibrary.org](http://www.fullertonlibrary.org) under the "Holds" tab in "My Account."

Once you have been notified that your items are ready, call the library Monday through Friday from 11:00 a.m. to 4:00 p.m. at (714) 738-6333 to make an appointment to pick them up. You will have 14 days from the time of notice to pick up your materials. (If you can't call, send us an email at [info@fullertonlibrary.org](mailto:info@fullertonlibrary.org).)

Due to high demand, the library requires a minimum of two to three full business days to process requests. (During this time there may also be a slight delay in our ability to reach out to you by email or phone.) We ask you to be patient as we work hard to fulfill your requests while taking extra precautions, including quarantining returned books for 96 hours, to ensure your safety.

Returns are not accepted during curbside pickup. To return your items, please use the outdoor book drop between Monday at 9:00 a.m. and Friday at 4:00 p.m.
