ATTENTION FULLERTON BUSINESSES:

Governor Newsom Issues Limited Stay at Home Order to Slow Spread of COVID-19 Effective Saturday, November 21, 2020.

On Thursday, November 19, 2020, Governor Newsom issued a new "Limited Stay at Home" Order for all counties currently in the most restrictive "Purple" Tier. Orange County was placed into the Purple Tier on Monday, November 16, 2020. Effective 10 PM on Saturday, November 21, and until December 21, 2020, all non-essential businesses and personal gatherings are prohibited under the Governor's Order between 10 PM and 5 AM. What does this mean for businesses located in Fullerton? Since Orange County is within the Purple Tier of the Governor's response plan, all businesses with Orange County must follow the Order and not conduct business between 10 PM and 5 AM. CARES Act Outdoor Dining Grants

The City of Fullerton is offering eligible restaurant businesses impacted by the COVID-19 pandemic an opportunity to receive a one-time grant up to \$1,500 to purchase eligible outdoor heat lamps, lighting, and/or canopies to facilitate compliance with State and County public health mandates. All purchases must be used for outdoor dining within Fullerton and be compliant with the Fullerton Fire Department standards attached. Attached is the one page application form.

Additionally, the County of Orange has announced the Orange County Restaurant Outdoor Dining Grant Program. This grant program is a first come, first served basis to support over 1,000 restaurants in the County offering outdoor dining.
