

POLICY FOR BOUNCE HOUSE IN CITY PARKS

The City of Fullerton desires to provide safe parks and recreational opportunities for all residents and visitors. The following policy applies to the use of bounce houses at all Fullerton parks:

Rules:

- 1. Use of a bounce house is ONLY allowed with reservation of a park site.
- 2. Users must obtain a Park Permit for the use of the park.
- 3. An additional fee of \$45 for Hillcrest Park with access to a predesignated electrical outlet, or \$40 for other parks that will require use of a generator, plus a \$100 security deposit is charged for bounce houses.
- 4. The park user is responsible for all damage caused by their use of the park or the bounce house. Damage to City property may result in the loss of the \$100.00 deposit.
- 5. Bounce houses must be rented from a company that has an approved copy of the liability insurance policy on file with the City and has agreed to comply with City rules as noted below:
 - a) Bounce house users will be responsible for providing a generator for inflation of the bounce house for all parks except Hillcrest. The generator will be one noted as "quiet" and not generate noise more than City standards. The generator shall be placed a safe distance from the bounce house.
 - b) Bounce houses must be free standing and weighted. Stakes are strictly prohibited.
 - c) Bounce houses must be placed in a safe area away from private residences and may not impede on other City permitted activities including, but not limited to, athletic field use.
 - d) Bounce houses are not allowed in City parks overnight.
 - e) The City is not responsible for any damage to the bounce house.

Bounce houses are permitted in the following parks ONLY:

- Acacia Park
- Adlena Park
- Brea Dam Park
- Byerrum Park
- Chapman Park
- Ford Park
- Gilbert Park (near tot lot)
- Hillcrest Park Pavilion

- Independence Park
- Laguna Lake Park
- Orangethorpe Park
- Pacific Drive Park
- Richman Park
- Rolling Hills Park
- Woodcrest Park



APPROVED BOUNCE COMPANIES

Below is a list of the Bounce companies that have their liability insurance on file with the City of Fullerton.

If you decide to choose a bounce company other than the one on this list, you may. However, the company you choose must provide us with a copy of their liability insurance, which includes a certificate of insurance and a certificate of endorsement. At least six weeks prior to your event, so it may be approved by our Risk Management Department.

The minimum requirements are:

- 1. General Aggregate \$2,000,000
- 2. Each Occurrence \$1,000,000
