#### **ADDENDUM NO. 1**

**TO: ALL PLAN AND SPECIFICATION HOLDERS**

THIS ADDENDUM, AS DESCRIBED BELOW, IS FOR USE OF CONTRACTORS AND SUBCONTRACTORS SUBMITTING BIDS ON THIS PROJECT. ALL BIDDERS SHALL INDICATE ON THE BID PROPOSAL FORM THAT THEY HAVE RECEIVED THIS ADDENDUM.

#### **CHANGES TO THE INVITATION TO BID:**

1. The time of completion of contract shall be **one hundred and seventy (170) working days**.

#### **CHANGES TO THE SPECIAL PROVISIONS:**

2. Add to SECTION 1-5 TRAFFIC CONTROL.

Due to the size of the project, for the well-being of the residents, this project will be split into four (4) phases.

- I. Phase I will consist of all water work on Las Palmas Dr.
- II. Phase II will consist of all water work on Potrero Dr, Las Rendas Dr, and Tunales Dr.
- III. Phase III will consist of all water work on Twilight Dr, Lovell Pl, Sunny Hills Rd, Teton Dr, Rosehedge Dr, and Greenmeadow Dr.
- IV. Phase IV will consist of all trench restoration throughout the entire project.

No work on a subsequent phase can begin until the previous phase has been completed, up to and including abandoning the water main, setting the new meter boxes, and installing new concrete pads, without written permission from the Engineer. Liquidated Damages of \$1,000 per calendar day will be assessed for every day of overlap between phases.

#### **CHANGES TO THE BID DOCUMENTS:**

3. Replace **BID ACKNOWLEDGEMENTS** with attached **Rev. 1**.

**END OF ADDENDUM**

**BID ACKNOWLEDGEMENTS Rev. 1**

1. The undersigned will execute the Agreement and furnish the required statutory bonds and certificates of insurance within **21 calendar days** after notice to him of acceptance of his Bid by the City and shall complete said work within **one hundred and seventy (170) working days\*** from the date specified in a written notice to proceed.
2. The undersigned agrees that the quantities given in the unit price of Bid Schedule and in other Contract Documents are approximate, being given only as a basis for the comparison of bids, and the City of Fullerton does not expressly or by implication agree that the actual amount of work will correspond therewith, but reserves the right to increase or decrease the amount of any class or portion of the work or to omit portions of the work, as may be deemed necessary or expedient by the City of Fullerton.
3. The undersigned agrees that the price for each item of work includes all applicable taxes.
4. The undersigned agrees that the liquidated damages shall be **\$2,000 per calendar day**.
